# Regional CONFINTEA VII Follow-up

### **Conference for Asia**

### Background

The seventh International Conference on Adult Education (CONFINTEA VII), which took place in Marrakech, Kingdom of Morocco, from 15 to 17 June 2022, took stock of the challenges and identified future priorities in the field of adult learning and education (ALE) within a lifelong learning perspective, in the context of the United Nations' 2030 Agenda for Sustainable Development. It was the first CONFINTEA to take place since the adoption of the Sustainable Development Goals (SDGs), and the most significant event for the international ALE community in the lead-up to 2030, the target year for the achievement of the SDGs. The discussions and agenda of CONFINTEA VII were informed by the outcomes of the regional and sub-regional preparatory conferences, which identified specific regional key issues, considered future prospects for ALE policy and practice, and suggested benchmarks and recommendations for global commitments.

The main outcome of CONFINTEA VII was the adoption of the <u>Marrakech Framework for Action (MFA)</u>. The MFA, which replaces the Belém Framework for Action (BFA), will play a significant role in guiding the development and implementation of effective adult learning and education (ALE) policies and practices over the next decade. The MFA sets out the key areas for action required to ensure equitable learning opportunities for all and to create a culture of lifelong learning through a holistic approach that encompasses all types of youth and adult learning (formal, non-formal and informal), and various learning sites, including in-person as well as online and blended learning. In particular, Member States committed to enhancing governance mechanisms and monitoring frameworks as well as improving the quality of adult learning and education backed by increased investment. Moreover, they committed to placing inclusion and gender equality at the heart of these endeavors to ensure that those most often left behind benefit from lifelong learning, have equal opportunities to learn and become active citizens.

Against these commitments, the UNESCO Institute for Lifelong Learning (UIL) together with UNESCO Bangkok office aims to organize a regional conference to promote the priority areas of the MFA and discuss the regional actions that could assist UNESCO Member States to meet those commitments in line with achieving the SDGs.

The conference will provide an opportunity to relevant stakeholders working in the field of lifelong learning and adult learning and education (ALE) to engage in in-depth discussions, drawing on their distinctive national experiences and perspectives to determine the tools and mechanisms necessary to establish an inclusive lifelong learning systems and gender-responsive ALE. The main outputs generated during the conference will be summarized and formulated as action points geared towards meeting the commitments made in the MFA.

### Aims:

The overall aim of the regional conference is to determine feasible actions on regional and national level to support Member States in Asia, namely Southeast Asia, East Asia and South Asia to develop and implement inclusive youth and adult learning and education policies and activities within a lifelong learning perspective and thus meet the commitments made in the MFA.

#### Main objectives:

- To contextualize the Marrakech Framework for Action and identify <u>areas of action</u> and for cooperation.
- To identify and share good national practices and innovations in adult learning and education, in particular in the key priority areas for the region (e.g., legal, fiscal or governance measures to advance lifelong learning systems, flexible education pathways and instruments to advance equity and stakeholder collaboration)
- Agree on a regional follow-up mechanism (such as an online community of practice) to take stock of the implementation of the regional action points and to allow for exchanging experiences and good practices on regular basis.
- Outline prospects on monitoring mechanisms, ALE budget, forward-looking strategies and <u>ALE's role in the region</u> in light of the SDGs and <u>Bangkok Statement</u> adopted in APREMCII in June 2022; and identify key action points for the implementation of the MFA.

#### Main expected outcomes:

- The Marrakech Framework for Action is presented and gaps, priorities and needs are analysed with reference to the recommendations outlined in the MFA.
- Feasible action points are identified to implement and meet the commitments made in the MFA with a focus on policies, funding, provision and quality and governance, as well as monitoring and evaluation.
- A follow-up mechanism is introduced to track progress made in implementing the agreed regional action points and exchange good practices (in particular in the key priority areas of the region).
- Resources and materials to support implementation are accumulated into the communities of practice (CoPs) hosted on the UIL Learning Hub
