Monitoring and Evaluation Towards Sustaining Equitable Education

I. [Summary of Discussion](#)

The EEA Secretariat announced [the 8th EEA webinar](#) was successfully held, and webinar details have been shared with EEA members who have participated in the closed-door meeting.

Representatives from Equitable Education Fund Thailand, UNESCO Bangkok, VVOB, Global Partnership for Education (GPE), UNICEF Nepal and Thailand, UNHCR, Ministry of Education of New Zealand attended the 8th closed-door meeting to update the progress of their programmes, and exchanged ideas on the future development of EEA.

II. [Status Updates of EEA Identified Activities & Discussion](#)

1: UNESCO Bangkok- [Equity and Inclusion in Education](#) EdX online professional development course introduction and promotion

- a. Introduced online course promoting progress and data updates of new registrants, up to now more than 3,260 Enrollments on EdX and 149 countries represented.
- b. Global promotion of online courses with multi-language subtitles, and subtitles are available in English and Thai. UNICEF Laos is translating course subtitles into Lao, and UNESCO Bangkok team is producing Chinese subtitles.
- c. Identified online course partnership potential in collaboration on multilingual subtitles translations and other future partnership opportunities.

2: GPE - Progress on GPE's "Leaving No One Behind" mission

- a. GPE 2025 operating model consists of several mechanisms, including inclusive policy dialog and prioritization, financing instruments, and learning and accountability for ensuring no one is left behind
- b. Explained the principles for working on 'leaving no one behind' through the GPE model¹ to pilot innovative approaches and learning, considering needs of disadvantaged groups within "mainstream" activities, support a large-scale, sustained and adaptable system, and system-wide reforms to improve school readiness, efficiency and progression of the learner.
- C.** GPE gives recommendations for development partners on work towards 'all children learning', such as adapting to the needs of an increasingly diverse body of learners, focusing on access and completion, all children learning, and public resources.
- d. GPE is looking for blog series collaboration with EEA members on inclusive education, as well as other related topics.

3: VVOB- Progress of mapping exercise

- b. Updated statistics for current members of the EEA, which has 22 local and international organization members who come from 17 countries as of September 2023.
